



## **CTC Clinical Duties**

- Check list and protocol completion
- Confirm and remind patient
- Arrange transportation
- Ensure translation
- Communicate and Coordinate
- Technical expertise
- Advocate for patient
- Paperwork completed



### Clinical Protocols

- Protocols are developed to ensure quality consults
- Provider or specialty specific
- Ensuring the specialist has all necessary information and tools to complete the assessment
- Ensuring special issues specific to the type of consult are addressed

### Included in Protocol....

- Preliminary tests and paperwork
- Equipment
- Nurse presence
- Added privacy steps
- Patient preparation
- Post consult care

## Example Protocol....

#### Protocol for Telepsychiatry Consults

- Follow Telehealth Consult Checklist
- Follow Soundproofing Protocol
- Sign "Oath of Confidentiality" in front of the patient and have patient witness your signature (following explanation of the form). Confidentiality must be maintained at all times and for all consults. It is important that patients attending these appointments have extra reassurance that everything is private and confidential.
- Have the Consent to Disclose Personal Health Information form available (It
  is the psychiatrist's responsibility to explain the form and then observe the
  patient signing). You will then witness the patient's signature. This is signed
  so that the Psychiatrist can send information to the patient's chart after the
  session.
- Mental Health Worker or designate must be available during and after the consult in case the patient needs additional mental health support.

## Spontaneous Consults

- Usually urgent in nature and often after hours
- Equipment may be moved to treatment room
- CTC arranges connection and view
- Invaluable for visual guidance by out of community expert
- Can assist in time saving treatment decisions
- Examples of recent use:
- Our sixth telebaby delivery (when weather is out, usually premature)
- MVA assessments and medivac to Winnipeg for surgery rather than Sioux Lookout first where treatment needed was not available



## Sioux Lookout Diabetes Program

- Nurse/Dietitian team seeing patients in SLZ by referral
- Before KOTM partnership most patients seen 1-2 times a year during fly in visits
- Now able to see patients quickly and regularly by video conference
- 600 successful consults 2008
- Visits can be as technical as Insulin start





## **Group Clinical Events**

- A clinical event is referral initiated with a patient receiving care from a health care provider
- No personal health information is shared
- The patient consents to the group format of the visit

## **Examples of Group Consults**

- Maternity Centre Prenatal Group
- Pain Clinic
- Cholesterol classes
- Weight loss classes
- Diabetes Education

- Group Clinical events require a combination of clinical and educational programming elements
- Patient: notification and confirmation to attend, transportation
- Clinical Scheduling
- Multiple site coordination
- Poster and hand out distribution
